Steps to navigate through the Ease of Doing Business in Assam Portal

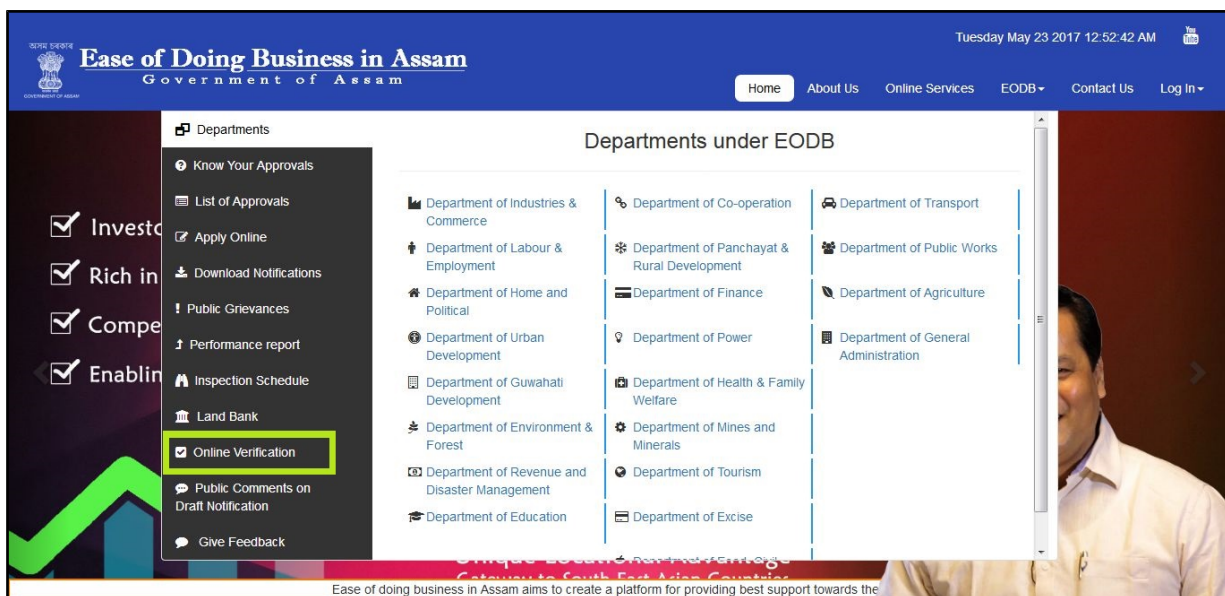
Online Application

1. To reach Ease of doing business in Assam home page follow

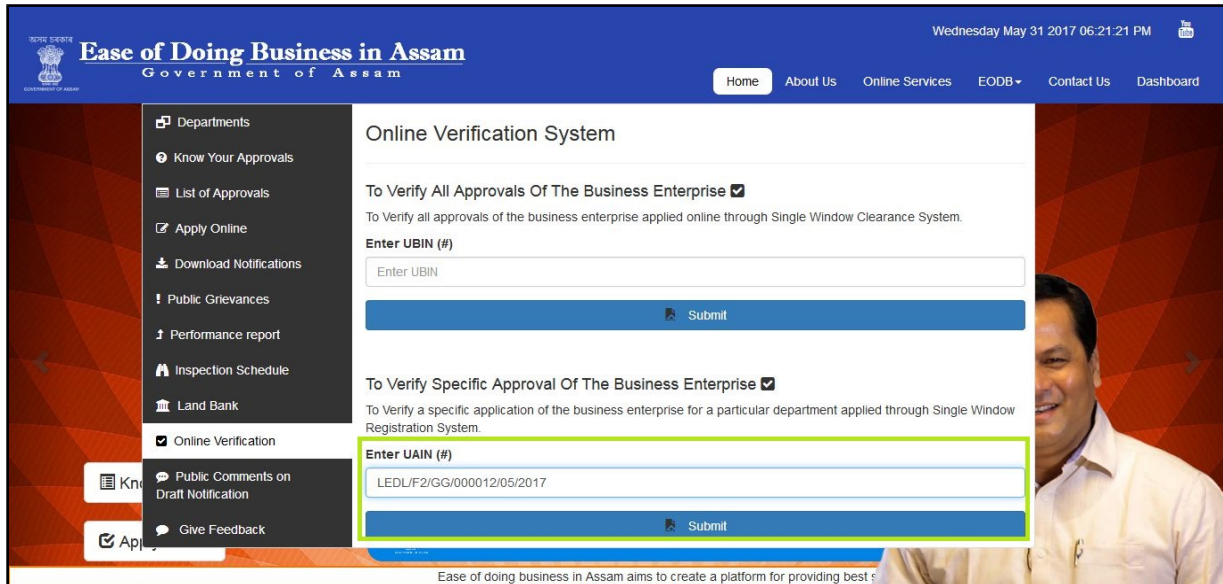

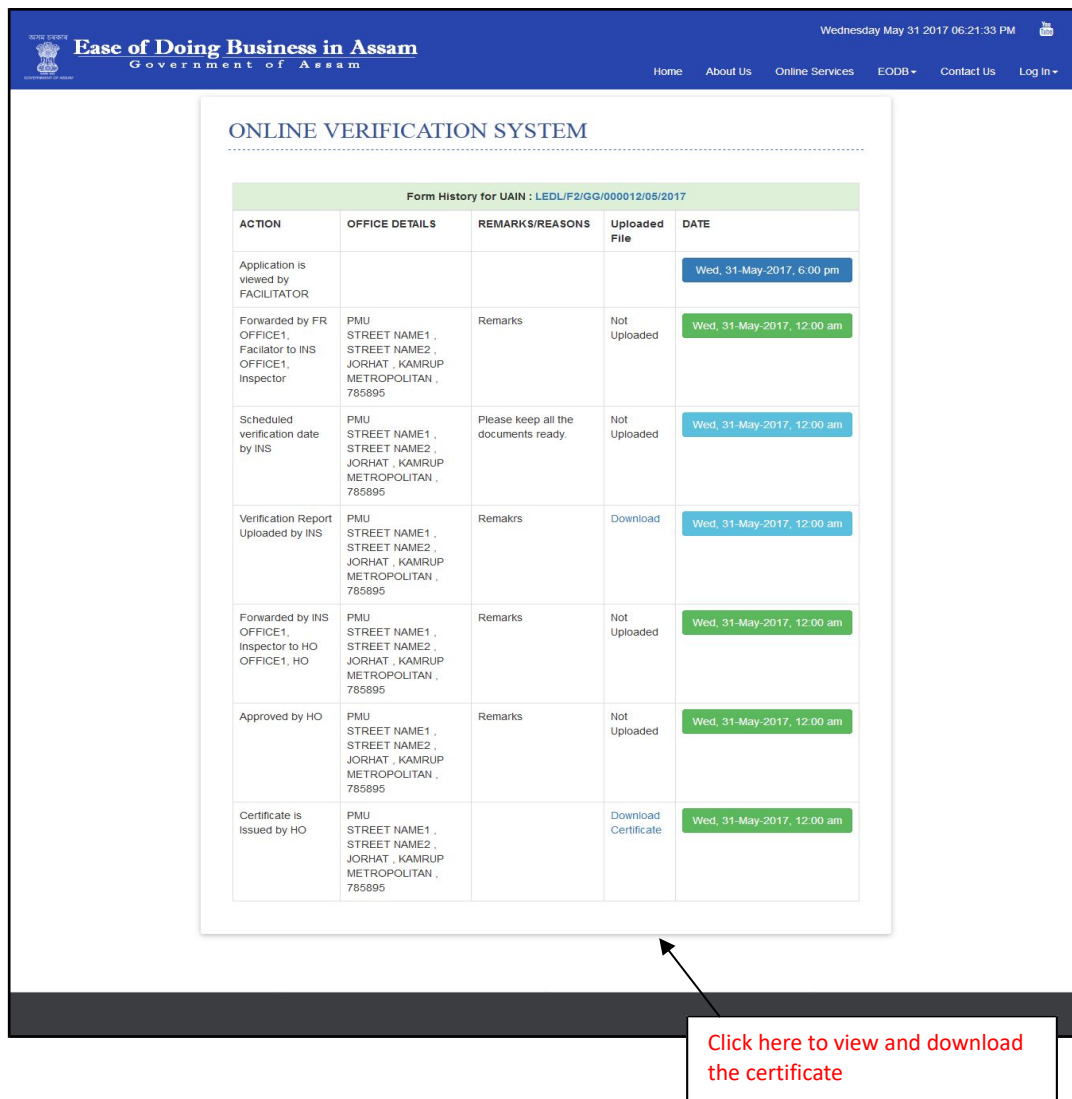
2. Click on EODB, where you can find online verification link in the EoDB dropdown.
